Code of Conduct

The Saskatoon Stock Car Racing Association (SSCRA) is committed to providing a fair, safe, respectful, and competitive environment for all drivers, teams, officials, volunteers, and spectators. This Code of Conduct outlines the standards expected from all individuals involved in SSCRA activities and events. These standards apply to all SSCRA members and guests, both on and off the track, including at events hosted by affiliates or governing motorsport bodies.

Note: Where a conflict exists between this Code and SSCRA Bylaws or sub-regulations, the SSCRA Bylaws and sub-regulations take precedence.

Scope

This Code applies to:

- All members, drivers, crew, officials, volunteers, guests, and spectators attending or participating in SSCRA events.
- All representatives of the SSCRA at affiliated events or when participating under the SSCRA name.

Off-track conduct that could negatively affect SSCRA's reputation or the safety and harmony of its community.

Disciplinary Action

Violations of this Code may result in:

- Verbal or written warnings
- Suspension or removal from the event or facility
- Temporary or permanent loss of SSCRA membership or racing privileges
- Reports to law enforcement if conduct is potentially criminal

Disciplinary actions are at the discretion of the SSCRA Executive or appointed officials.

Compliance with Local Laws

SSCRA operates under the jurisdiction of the Rural Municipality (RM) of Corman Park (or relevant municipality) and all participants must comply with:

- Municipal regulations and bylaws
- Provincial and Federal laws and regulations

Racing Conduct

All participants are expected to:

- Compete fairly and adhere to all racing rules, technical specifications and regulations
- Respect the authority and decisions of officials at all times
- Never encourage unsafe driving, rule violations, or retaliation
- Show sportsmanship and avoid offensive, threatening, or disrespectful behavior
- Use only approved safety gear as per current regulations (helmets, suits, gloves, boots, etc.)
- Assess their own skill level and take responsibility for the associated risks

Prohibited on SSCRA Premises

The following are strictly prohibited within Pit areas:

- Smoking and/or vaping is restricted to approved areas
- Alcohol consumption
- Cannabis use
- Illegal drugs
- Possession or use of performance-enhancing substances

General Conduct

All SSCRA members, participants, and guests must:

- Follow all SSCRA rules at events and when representing the organization elsewhere
- Complete the online waiver prior to entry to the pits (<https://sasktel.speedwaiver.com>)
- Respect officials, fellow racers, volunteers, and fans
- Maintain a friendly, inclusive, and safe atmosphere
- Keep pit areas, stands, and facility grounds clean and free of pollutants and unsafe conditions
- Promote enjoyment and community of our facilities
- Be cautious and supportive in the presence of injuries or illness. Respect privacy
- Act as positive role models for the sport and younger participants



SpeedWaiver

Discrimination & Harassment – ZERO TOLERANCE

SSCRA does not tolerate discrimination or harassment of any kind. All members and attendees must:

- Respect the dignity and worth of all individuals, regardless of body type, race, gender, orientation, religion, age, ability, or socioeconomic status
- Refrain from:
 - Verbal or written abuse
 - Racist or sexist comments
 - Sexual harassment or inappropriate physical contact
 - Hazing, bullying, intimidation, or retaliation
 - Display of offensive materials or gestures
 - Any action that creates a hostile or toxic environment

Social Media & Communications Conduct

All SSCRA members and representatives must:

- Avoid public criticism of officials, racers, teams, or volunteers
- Not distribute false, misleading, or harmful content via email or social media
- Avoid posting derogatory or abusive comments related to SSCRA events, individuals, or partners
- Adhere to all SSCRA privacy and communications policies

Acknowledgment

All drivers, team members, volunteers, officials, vendors, and spectators agree to:

- Comply with this Code of Conduct as a condition of participation
- Accept the final interpretation and enforcement of this Code by SSCRA officials and the Executive Board
- Utilize the appropriate complaint procedure if an issue arises in the absence of an SSCRA official
